WORSHIPFUL MASTER OF THE YEAR

ELIGIBILITY:

- ✓ Any Worshipful Master (W.M.) who is a member in good standings of a Lodge currently chartered by the MWPHGL State of Washington and Jurisdiction.
- ✓ A W.M. **must be nominated** by his District Deputy Grand Master (D.D.G.M.).
- ✓ Nominations **must arrived** by established deadline.

NOMINATIONS:

- ✓ Each D.D.G.M. may nominate **ONE** eligible W.M. from his respective District.
- ✓ Nominations **must be typed, double-spaced** and must not exceed **two** pages.
- ✓ Nominations must include full name of the W.M. and name & number of the W.M. Lodge
- ✓ Complete package **must be signed** by the applicable D.D.G.M. and forwarded to the following address:

SELECTION CRITERIA:

All Awards Packets from D.D.G.M.s must be complete and returned to address listed above, post marked **not later than 1 May 2012**. All packets post marked after the deadline date **will not be considered**.

NOTE: In accordance with established criteria and guidelines, the Annual Award Committee will have sole jurisdiction over the manner in which the packets are reviewed and considered. The committee will make its recommendations to the **Grand Master whom will have final decision on the selections**.

- ✓ The Lodge must be nominated by his District Deputy Grand Master (D.D.G.M.).
- ✓ Nomination Packets must arrive by established deadline

NOMINATIONS:

- ✓ Each D.D.G.M. may nominate **ONE** eligible Lodge from his respective District.
- ✓ Nominations **must be typed, double-spaced** and must not exceed **two** pages.
- ✓ Nominations must include full name and number of Lodge
