## MASTER MASON OF THE YEAR

### ELIGIBILITY:

- ✓ Any Master Mason (M.M.) who is a member in good standings of a Lodge currently chartered by the MWPHGL State of Washington and Jurisdiction.
- ✓ A M.M. **must be nominated** by his Worshipful Master (W.M.).
- ✓ Nominations **must arrived** by established deadline.

### NOMINATIONS:

- ✓ Each W.M. may nominate **ONE** eligible M.M. from his lodge.
- ✓ Nominations **must be typed, double-spaced** and must not exceed **two** pages.
- ✓ Nominations must include the full name of the M.M.
- ✓ Nominations must include full name of the M.M. and name & number of the M.M. Lodge
- ✓ Complete package **must be signed** by the W.M. and forwarded to the following address:

### SELECTION CRITERIA:

Nomination packets (write-ups) must comprised statements from the following areas; to be written in **“Bullet Format”** to include **what was done--how it was done--and what effect** it had upon the Grand Lodge, District, Lodge or community:

#### **Example:**

**Brother Jones spearheaded the lodge Annual Christmas Party; his contribution was instrumental in the donation of toys to children in the local community.**

Below are the following compromised areas that must be represented in the submission:

- ✓ **Ritualistic Proficiency**
- ✓ **Support of Lodge Programs**
- ✓ **Community Involvement**
- ✓ **Self Improvement**
- ✓ **Masonic Knowledge**

### WHERE TO SEND COMPLETED PACKETS:

All Awards Packet from W.M.s must be complete and returned to address listed above, post marked **not later than 1 May 2012**. All packets post marked after the deadline date **will not be considered**.

**NOTE:** In accordance with established criteria and guidelines, the Annual Award Committee will have sole jurisdiction over the manner in which the packets are reviewed and considered. The committee will make its recommendations to the **Grand Master whom will have final decision on the selections**.

The names of nominees will be announced at the Annual Grand Session and winner announce at the Annual Awards Banquet.
