The Purpose of Headquarters Lodge No. 75:

- The Headquarters Lodge is to act as a Holding Lodge for our overseas and other distant members , until such time as they can join a regular chartered lodge. It may contact and restore any Master Mason, who was a member of this Jurisdiction, that had been suspended for non-payment of dues by a chartered Lodge after he has been out of his Lodge for three ((3) or more years or the lodge in which he last held membership is closed.. After being restored to current status, he must join a regular chartered lodge


There are three primary function of Headquarters Lodge No. 75

- Reinstatement- once a reinstatement packet has been reviewed and approved
- Transfer- when a lodge has been closed and the Most Worshipful Grand Master has directed the transfer of those members to Headquarters Lodge No.75
- Demit- When a member in good standing within Headquarters Lodge No.75 has requested a demit to a regularly chartered lodge.

- The fees are \$200.00
 - \$150.00 for dues
 - \$50.00 advance demit fee
- Transfer- \$150.00 current year dues

- Once submitted the form is sent to the Chairman within minutes
- Within 48 hours the Chairman will contact the requester and explain to him the reinstatement process and fees
- Within 48 hours the committee will send out a reinstatement packet
 - The packet consist of three forms:
 - Letter of Instruction
 - Personal letter from requester about lodge history
 - Petition for Reinstatement
- Once the packet is returned from the requestor with a copy of his last lodge dues card and/or Masonic Birth Certificate
- If the petitioners packet is found acceptable and approved, it will be forwarded to the lodge in question for processing. If that lodge is Headquarters Lodge, the petitioner will be sent an email as noted below,
- Upon approval by the lodge an email to the requestor letting him know the status of his reinstatement and address to which he should forward the required funds.

- The process used by the Reclamation Committee is to tracked all reinstatement request to ensure accountability and files are retain in an archive.

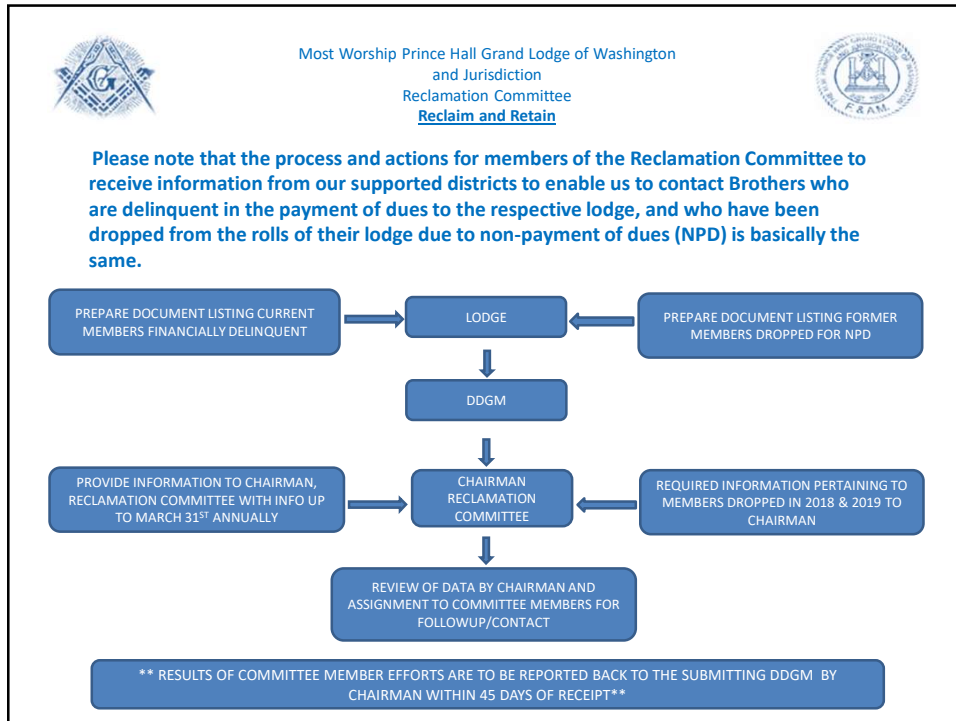
