Proclamation 21-003

“Election, Installation of Lodge Officers Submission of Election Certificates”

To: All Worshipful Masters, Past Masters, Wardens, Officers and Members of All Lodges belonging to the Most Worshipful Prince Hall Grand Lodge F. & A.M. of Washington and Jurisdiction

WHEREAS, Pursuant to Masonic Code, Part III, Title 102, Section 120.01:01, Title 105, Section 105.01 and 105.02 and Title 106, Section 106.01 and 106.05 of the Masonic Code of the Most Worshipful Prince Hall Grand Lodge, Free and Accepted Masons, Washington and Jurisdiction; all constituent lodges of this Grand Jurisdiction shall Elect, Install and submit a Certificate of Elections to the Grand Lodge, Office of the Grand Secretary with the names of the Worshipful Master, Senior and Junior Wardens, Secretary, Treasurer and Trustees not later than **December 31, 2021 A.D., 6021 A.L.**


WHEREAS, should any constituent Lodge for any reason fail to conform to this Proclamation as written, that lodge must secure a **Special Dispensation** from my office to elect and install into office beyond December 31, 2021 A.D., 6021 A.L. and

WHEREAS, the names, addresses, ZIP / APO Codes, Area Codes, Emails and Phone Numbers of all Elected Officers as well as the names and title of the Installing Officer shall be forwarded to the Grand Secretary's Office not later than January 15, 2022, A.D., 6022 A.L. and

WHEREAS, Due to Government Social Mandates and Restrictions which continues in place with regards to meeting as a result of the Coronavirus (COVID-19) or any related Variant thereof the method of conducting Elections Virtually is an acceptable and safe option of Electing said Officers to serve for the calendar year 2022 if the lodge desires to use this method of conducting Elections, now, therefore, be it

RESOLVED, that I, Gilbert E. McClary, Sr., by the power and authority vested in me as Most Worshipful Grand Master in and for the State of Washington and Jurisdiction, do hereby direct all Master Masons to take due and timely notice thereof and govern yourselves accordingly and safely


